- In 2006, spear-headed the establishment of two charitable trusts: Whangarei Accessible Housing Trust (WAHT) and Te Puu Ao Charitable Trust. WAHT was established to meet the urgent housing need of people with disabilities in the region and in partnership with communities, philanthropic trusts, and central government the trust secured funding resulting in a housing portfolio of 28 houses in Whangarei and Auckland.
- Currently employed at the Northland Regional Council, newly appointed to the General Manager role for Governance and Engagement.

More importantly, I love the people and communities in our sport and will bring all these skills and experiences to be of service to our clubs and regions so that our mokopuna can continue to thrive in this beautiful sport and kaupapa of waka ama – outrigger canoeing in Aotearoa.
