SUBMITTING INTENTS ONLINE

- Club representative to place intention via <https://www.wakaama.co.nz/members-area/> as an online entry in the [IVF Va'a World Sprint Club Championship 2024, Hilo Hawai'i TEAM INTENTS](#)
- Please ensure your team is entered into each event they wish to qualify for i.e. W6 500m, W6 1000m & W12 500m
- Payment must be made for intent to be confirmed - online entry will be updated to reflect payments received
- We do not need any paddler names at this stage - only team entries

PAYMENTS

- Payment must be made for intent to be confirmed
- Each team pays the intent fee once (regardless of the number of events entered) **\$1800 per team intent** (\$300 x 6 - *if the selection is confirmed then reserve/extra paddler fees will be invoiced to the club at that time*)
- We will accept payments per team (with their team as the reference) or one payment per club with the club name as the reference.
- WANZ will invoice clubs on request and send any final invoices on the 23rd of November 2023.
- Your Intent fee becomes your entry fee if your team qualifies.
- **Teams cannot qualify without completing the intent process**
- If your team does not qualify - you will be refunded the full intent fee
- **Total payment: \$1800**

| Online Intent process will open 2 October 2023 for clubs to submit their intent to trial to participate at the 2024 IVF World Club Championships | 2 October 2023 |
| <p>The intent process will require the club to register a team and category/ies. No paddler names will be required for this registration of intent.</p> <p><i>Please note that the name of the team must be the same team name that they use when they enter the Sprint Nationals in 2024.</i></p> <p>Only teams with intents submitted will be eligible to qualify for the 2024 World Club Championship</p> | |
| The intent must be accompanied by the Entry Fee to the World Club Championships (\$300 per paddler/\$1800 per team) This fee is only refundable if there are more than 6 teams that register intent, and your team does not qualify. If the team qualifies, then this amount will be used as their Entry Fee to the IVF. | |
| Intent and fee due by 23rd November 2023 | 23 November 2023 |
| Teams must qualify in 500m, 1000 /1500 W6, W12 and turns races separately. (Meaning it is possible that a club may choose/qualify to go to the World Club Championships in one event only). | |
| After teams have qualified, the club has until 30 January 2024 to confirm that they are taking up the spot. | 30 January 2024 |
