#### **Entries and Race Information**

All entries must be completed by the Club Administrator, waivers will be done online and must be completed at the same time entries close. All entries need to be verified members of NKOA. New paddlers must have completed their NKOA ID process.

Late entries will not be accepted

#### **Updated Race Format**

W6 – 250m heats for all categories, with the fastest 4 teams progressing to the finals

W6 – 500m heats for Intermediates to Master 80, with the fastest 4 teams progressing to the finals

W12 – 250m heats for all categories, with the fastest 4 teams progressing to the finals

W12 – 500m heats for Intermediates to Master 80, with the fastest 4 teams progressing to the finals

W1 – 250m - one race only per paddler, eg. Open **OR** Masters. J19/Open Nationals Quota will be filled by the fastest times overall.

W1 – 500m - one race only per paddler, eg. J16 **OR** J19. Nationals Quota will be filled by the fastest times overall.

### **W1 Nationals Qualification Information**

This is the qualifying event for the 2024 NKOA Sprint Nationals. Paddlers may only paddle for one club. Regions are allocated 4 entries for each race division plus extra quota for having finalists in the previous year's nationals. The quota will be filled from placings in each race division.
