Waka Ama New Zealand - Ngā Kaihoe o Aotearoa Board - Chair Report

E ngā mana, e ngā reo, tēnā ra koutou katoa

For this (my second) Board report I would like us all to reflect on the different roles we play as members of a large sporting whānau – and to think of the meaning of the word whānau, and why we prefer to use that word rather than the more common word 'family'.

I've just come back from seeing some of my own whānau, including my son Logan, his wife Sally and my moko Tahiwai, who all now live on the Gold Coast, in Coolangatta, Australia. Visiting relatives helps us see what our Australian cousins are like as a nation, lapped as they are by a combination of great beaches and huge river water ways. No wonder they have good surfers! That got me to thinking about their approach to the development of the sport of waka ama – what huge advantages Ozzies should have with their wonderful wide beaches and warm water and weather. The Gold Coast will be a wonderful place to visit for the next Commonwealth Games. But these visits also remind us of what we have to be thankful for here.

I think there is one particular aspect of the sport which is our 'trump' card. The waka ama community in New Zealand/Aotearoa is really like a very large whānau (or maybe that's a collection of large whānau). This aspect doesn't necessarily make the sport unique among New Zealand sports, because many our sports codes (if they have any sense) aim to foster those feelings of passion and loyalty and sense of collective care (and overall New Zealanders do pretty well at fostering those positive values in our sports teams).

However, waka ama in New Zealand/Aotearoa is unique. And what makes it unique? Well, you might also ask what makes a whānau unique? Here are some elements worthy of considered reflection: first, we have a growing numbers of paddlers, but our community is still small enough numbers-wise to enable us to personally know who key club members are across the nation. Second, waka ama provides opportunities for paddlers and administrators to engage with lots of other paddlers and administrators from different walks of life, from all age groups and from different cultures. Third, members of our clubs often span a number of generations – we are very comfortable with the idea of different age groups being an important part of the operational process. In addition, both genders are expected to play leadership roles in our sport, and there is a place for the able and the less able, the competitive individual and the social animal in the whānau. However, as in many New Zealand whānau now, although you see a mix of cultures, Māori culture and tikanga plays a vital role in bringing those different mixes and roles together. It is the concept of whānau and the values that sit behind the notion of whānau that help glue the diverse elements together. Most important of all, a stable whānau works solidly and positively together for the common good.

That is the quality I have seen develop in 2013. The (no longer) 'new' Board/Operations framework is in place, with clear policies and procedures in place and the strategies for the next three years clearly established. We are operating like a stable whānau should. In 2013 we took our opportunities to formally farewell whānau members we have lost, like Nana P. We are continuing to develop a sense of surety about the right and appropriate direction we should be taking for the sport as a whole. We are learning the art of co-constructing solutions to issues in our attempts to meet our different needs – local, regional, national and international. So, whether you are a member of a small club struggling for numbers or in a large one trying to ensure the infrastructure can handle a big event; whether you are already a world beater or there for the love of paddling; whether you have been on a sub-committee whose main purpose is to buy the club a new waka, or decided instead that you might take up coaching a team of midgets, there is a role for everyone to play in this whānau.

It's important for us to remember to pat ourselves on the back every now and then, and to quietly thank our mates who continue to make the sport available to others and who look for ways to ensure good experiences on the water. No reira, nga mihi ki a koutou katoa, ki ngā kaimahi o tēnei whanau waka ama.

These are also my specific thanks to all the Board whānau - to Dani, Tim, Paul, Caren and Ralph for your hard work this year. To our outgoing Deputy Chair Meka Whaitiri and to Caren Fox as our outgoing elected Board member. You have all contributed well to our whānau. Ngā mihi nunui. Thank you for your collective wisdom and passion.

Our thanks also to our wonderful CE Lara Collins and her growing team – Conan Herbert, Debbie and Amiria. You are leading our whānau well. You are creative, hard working and positive role models for us all.

And a special welcome to the two new Board members – the newly appointed member Trevor Shailer to replace Meka and to our recently elected member Cherie Collison. We know that your skills and knowledge will further strengthen the work of the Board from 2014.

In this, the 25th year of national competition, we have a life span already of one generation. Having completed the development of the historical time line and the history of waka ama competition results timeline on the web site, we now know who we are, where we come from and what we have accomplished. The concept of a virtual Hall of Fame to honour the past and the present in a meaningful way will add to that growing history. We can also start to really focus on our aspirations for the future. We are a whānau with purpose.

Chief Executive Report 2013

2012/2013 has been a fabulous year for Waka Ama as we continue to achieve strategic goals and work towards achieving our strategic plan.

Our new governance structure is now 2 years into its life and this AGM marks the end of the first term for 2 of our board members.

Many thanks to Paora Howe for his outstanding contribution as Board Chair, and to the Board Members: Meka Whaitiri - Deputy Chair (resigned), Caren Fox, Danielle Rouse, Paul Dahl, Tim Marshall and Ralph Ruka, who have taken on their role so professionally and thoroughly.

Congratulations to Meka Whaitiri on her election to Parliament, filling the seat of Pareikura Horomia, a long-time supporter and friend of Waka Ama who sadly passed away last year.

Unfortunately last year in August we also lost our Nana P. She was an awesome supporter of Waka Ama and Rangatahi and we will all miss her a lot at future Nationals, Secondary School Nationals other events. She was someone that you could rely on to be there like clockwork, and was always very supportive of everything we were trying to achieve.

The 12 months to the end of June 2013 saw our sports membership increase by 29%, which makes us one of the fastest growing sports in the country. This increase does not happen by chance and much effort has been made by clubs and regions throughout the country to increase their membership and assist to capture the true numbers of our sport. We still have some work to do in the area but we have come a long way and have certainly raised the awareness of our sport.

Our Waka Ama New Zealand office continues to grow and this year Conan Herbert joined our team as the National Development Manager. This is an exciting position and signals another milestone in our sport's history. We now have a dedicated focus on development, and Conan, with his skill and knowledge of the sport of Waka Ama, has proven in only 6 months that he is an outstanding addition to the team and we are fortunate to have him.

A big thanks to Debbie Sellar and Amiria Mita, who never cease to raise the bar in sports administration. Debbie's administrative skills and dedication are outstanding, and Amiria, who has become our project specialist, has completed our History Timeline and the historical record of results - along with many other projects throughout the year.

One of our strategic goals this year was to raise water safety awareness amongst our membership and our 'Tips and Tricks' Videos were well received, so much so that they will now feature on Maori Television during this coming year.

We have also created a new programme "Waka Ama Flip & Float". Our Flip & Float team, lead by Conan Herbert and including Amiria Mita & Turanga Barcley-Kerr, has travelled around the North Island and completed five Flip and Float sessions so far, with more planned for the coming months in the South Island, Napier & Whangarei.

Thank you also to our Sponsors New Zealand Post, who continue to support us as our major sponsor. Our relationship with New Zealand Post has gone from strength to strength. They have re-signed for another 2 years to take us to 2015, stating that Waka Ama has been one of their most successful sponsorship relationship to date. We appreciate New Zealand Post and value the contribution they have made to our sport since 2011.

Our partnership with Outward Bound will also see us being able to select at least another two members this coming year to attend Outward Bound courses.

Over the last 12 months we have also given away another 36 prizes in our monthly prize draws to our members. We plan to continue this initiative in the future with the possibility of some even larger prizes on the horizon.

In August this year the IVF World Sprint Championships will be held in Rio. We are anticipating around 120 paddlers from Aotearoa will attend the event. We look forward to following the journey of our teams and clubs as they build up to the event.

And as we look forward to all the opportunities ahead this year, we are reminded that this year, 2014, is the 25th year of our Sprint National Championships. The first nationals saw 17 clubs compete for national titles and this week we have 2600 paddlers from 54 clubs competing. The sport has grown from strength to strength over that time and it is to the credit of all the hard work by the mountain of volunteers, administrators and officials who have dedicated so much to our sport over those 25 years. I can't wait to enjoy all that the next 25 years brings!

Report on the Financial Statements

1. STATEMENT OF ACCOUNTING POLICIES

a. Reporting Entity

Nga Kaihoe o Aotearoa (Waka Ama New Zealand) Incorporated is a non-profit organisation registered under the Incorporated Society Act 1908.

The Incorporated society is to develop, promote and encourage all activities associates with Maori and Polynesian canoes, recognising and understanding the philosophy and across cultural exchange and sharing amongst the people of the Pacific.

b. Statement of Compliance

These Financial Statements have been prepared in accordance with New Zealand generally accepted accounting practice (NZ GAAP).

Differential Reporting

Nga Kaihoe o Aotearoa (Waka Ama New Zealand) Incorporated is a qualifying entity in that it qualifies for differential reporting as there is no separation between the owners and the governing body (or, is not large as defined under the Framework for differential reporting). All differential reporting exemptions have been applied

Basis of Measurement

The financial statements have been prepared on a historical basis with the exception of certain items for which specific accounting policies have been identified

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

Prior Year Comparatives

Certain comparative figures have been restated to comply with the current year disclosures.

Presentation Currency

These financial statements are presented in New Zealand dollars

Specific Accounting Policies

The accounting policies used in the preparation of these financial statements are set out below. The policies have been consistently applied to all years presented.

c. Revenue

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the entity and the revenue can be reliably measured. Grant income is recorded in the period to which it relates to.

d. Property Plant & Equipment

Property, plant and equipment are recorded at cost less accumulated depreciation and impairment losses.

Depreciation of property, plant & equipment is calculated using diminishing value tax rate so as to expense the cost of the assets over their useful lives. Depreciation of all assets is reported in the Statement of Comprehensive Income. The rates are shown below:

e. Goods & Services Tax

These financial statements have been prepared on a GST exclusive basis with the exception of accounts receivable and accounts payable which are stated GST inclusive.

f. Income Tax

No provision for income tax has been made as Nga Kaihoe o Aotearoa (Waka Ama New Zealand) Incorporated meets the Inland Revenue Department requirement for charitable status and has been granted an income tax exemption. Therefore there is no requirement to file an income tax return.

g. Receivables

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.
