Board Chairperson Report

This year, like those before, has been another exceptional year for Waka Ama New Zealand. At all levels of our sport, from international competition, through to national championships, club regatta, have-a-go days, whānau days or social paddling, we are providing opportunities for more people to get in the waka, and contribute to our vision of 'waka ama for all, for life'. Our achievements are highlighted throughout this annual report, and it is a pleasure to be able to share these with our waka ama whānau.

The board is pleased with our financial position. We have ended the financial year with a significant surplus which provides us with some financial security. Our strategic and funding relationship with Sport New Zealand is sound and continues to develop.

We are leading the national sports sector with our youth advisory ropū, Te Reo Taiohi, and the development of a youth specific strategy; Rautaki Rangatahi. A large percentage of our membership is under 19 and the Rautaki Rangatahi will ensure the voice of our young people is heard. We have begun the process of forming a disability working group, Te Ropū Whaikaha, which will also contribute to the strategic focus of the board and the organisation.

This year has been a year of reset from the disruption that COVID-19 brought to the world, country and our sport. Without this distraction, we have been able to focus on building an even stronger foundation – with work happening on building the capacity and capability of the board as well as growing the team of staff to deliver on our strategic priorities.

The Board began work on Governance Mark this year, with the support of Sport New Zealand and we look forward to seeing how this process will strengthen the overall governance of Waka Ama NZ.

We have had a few changes on the board this year. We have said farewell to our Deputy Chair, Scott Linklater, who served on the board for five years, and we have welcomed Frances Piacun and Irenee Cooper. We thank Scott for his contribution. We look forward to the unique skills and strengths that each of our new board members bring. We have also had a change in board chair, with Zalene Douglas standing down and Ngaire Pehi taking up that role. Turanga Barclay-Kerr has been elected Deputy Chair. Along with the changes at the board we have also had growth in our staff with three new staff coming on board this year each with a specific focus on our strategic priorities.

The year has not been without its challenges, however, with several of our regions and communities affected by cyclones and flooding. The impact of climate change is impacting our sport now and will continue to do so. How we prepare and mitigate, as well as reduce our impact on the climate, are all active discussions for our sport.

As our sport grows, so does the age of our participants, with one of our largest groups of participants being the 50+ age group. We have had some serious medical events at different regattas this year and we are working on improving health and safety awareness and procedures at all levels of waka ama, especially events.

Through the Sport NZ Governance mark work that the Board has undertaken, we are in the process of reviewing our current strategic plan and our strategic intent to ensure measurable outcomes that can be monitored and achieved. We look forward to sharing this with the membership over the coming months.

Our small team deserves praise; as board chair feedback has been received from different external sources commending their work and productivity. Our organisation is fortunate to have the leadership and team members we do. They have continued to build on previous years' work, they are innovative and hard-working, and we as an organisation can see the results of the work they do. Thank you to Lara and the team; your work is appreciated. The board also wishes to thank our six regional bodies, all our club committees and the numerous volunteers who contribute to the sport- without all of you, none of these achievements would have been possible.

To all our kaihoe and whānau, enjoy your paddling and we'll see you on the water!

Chief Executive Report

Tēnā koutou katoa,

There have been many highlights of the 2022/2023 year as we continue to develop waka ama throughout Aotearoa to achieve our vision; Waka Ama - mā te katoa, mō āke tonu! This annual report highlights our key activities, outstanding performances, and our overall outcomes.

Our sport has also faced some challenges over the past year and our waka ama whānau continue to show resilience through these times. It has become increasingly apparent that climate change, weather events and the effects on our treasured waterways are more concerning than ever. We are looking at ways to mitigate these impacts and provide leadership for our waka ama whānau in these spaces.

The Waka Ama NZ office continues to work towards achieving our strategic priorities; several strategic achievements are summarised below.

This year our organisation has transitioned into a new phase as we increased our workforce with new staff in three new roles. As a result of this process, our internal organisational policies and procedures have been strengthened. This process was heavily supported by Jocelyn Visser and the exceptional MyHR team. This increased capacity has already made an impact and will allow Waka Ama NZ to achieve more of our strategic outcomes and ultimately help our sport develop further.

We continue to champion waka ama and share our stories and our people, to not only raise the profile of waka ama but to recognise milestones and achievements of our waka ama clubs and whānau. We also celebrate waka ama through the delivery of outstanding national, regional and club events. We look forward to strengthening and resourcing this mahi in 2024. In the performance space, Aotearoa was strongly represented at the recent IVF World Distance Championships; topping the medal tally across 27 countries. The event was not without its challenges, however, Aotearoa as a contingent embodied the values of our sport throughout the competition. At the international level, our people continue to support the governance and development of Va'a through the International Va'a Federation. We have strengthened our relationship with High Performance Sport NZ and with the support of the newly refreshed Performance Advisory Committee, and we have started to streamline our processes and policies in this space.

This year we signed our first major merchandise partner - Pure Athlete. Chris and the team have provided us with exceptional services and we look forward to working with them in the coming years. Financially we have ended the year with a surplus along with healthy reserves. This will ensure we have the means to implement our strategy over the coming years to achieve our vision. We have spent much time developing our budget for the next year along with fiscal forecasts for the future. With a robust business plan and with the help of current and potential partners we hope to build a sustainable organisation that can support our sport at all levels to achieve its potential.

We have continued to develop significant targeted projects that align with our strategic plan such as Te Reo Taiohi, Te Rōpū Whaikaha and the Aukaha Project. The roll-out of these projects will aim to strengthen our infrastructure, capacity and collaboration, ensure our sport is diverse, inclusive and equitable for all communities, and provide opportunities for Aotearoa whānui to engage in waka ama at all levels. The establishment of Te Rōpū Whaikaha (WANZ Disability Working Group) will enable us to have a dedicated focus on inclusion in waka ama for tāngata whaikaha. Alongside the Rautaki Rangatahi, our Te Reo Taiohi Rōpū, and our implementation of Balance is Better principles, we will maintain our particular focus on Rangatahi and Tamariki who are the future of our sport. Our participation numbers are continuing to build with a positive increase of 43% from 2022 while highlighting there is work to be done with our clubs and regions to maintain growth and retain members.

At a sector level, our staff has continued to support and feed into Sport NZ initiatives and working groups. I would like to acknowledge our Sport New Zealand Relationship Manager, Andrew Corkill, who continues to support and advocate for our organisation and sport.

With the assistance of Sport New Zealand and our partnership with Storied Consultants, we have developed a revenue strategy to ensure sustainable income streams that align with our Waka Ama NZ values. This revenue strategy will aim to provide a targeted approach for new and current funders, partners, sponsors and philanthropists to achieve our strategic outcomes.

Finally, I would like to thank those who have had a significant impact on our organisation in the past year. Ngā mihi nui to the Waka Ama NZ Board for their support and leadership over the last year. A special thanks to Zalene Douglas for her guidance over her time as Board Chair. Our wonderful whānau of sponsors, partners and funders who supported Waka Ama NZ in the past year, we look forward to continued work moving into 2024. To the amazing staff of Waka Ama NZ; Amiria, Deb, Tara, Aroha, Jo & Trevor. Your dedication and professionalism ensure that our operations are seamless and that our whānau are at the centre of all that we do.

Thank you to all of our regions, clubs, volunteers and waka ama whānau for your continued support and dedication. It is the people involved and all those who have given their time over the decades that have gone before us, who have helped to make waka ama what it is today.

We look forward to 2024 as we build new partnerships and initiatives to continually grow and develop waka ama. Bring it on! Waka Ama – mā te katoa, mō āke tonu!

SPRINT NATIONALS

15 - 21 January 2023 Lake Karāpiro, Cambridge

The Waka Ama Sprint Nationals took place at Lake Karāpiro in January, supported by manawhenua Ngāti Koroki Kahukura and Ngāti Haua.

Event Overview

The event was welcomed back by 2700 paddlers from 63 clubs throughout Aotearoa after the event was cancelled in 2022. The event was inclusive of tamariki (children), rangatahi (youth), pakeke (adults), and kaumātua (elders), ages 5yrs-81yrs, adaptive paddlers, and paddlers of all ethnicities and cultures. There were 338 races over the seven days including heats, semis, and finals in W1, W6, and W12 categories.

The vendor lane, spectator bank, corporate race, and medal ceremonies were all notable inclusions at the event that added to the inclusive and whānau atmosphere. The vendor lane provided kai stalls, health stations, merchandise, and interactive activities for whānau and the corporate race provided some exciting racing for spectators from mostly novice paddlers representing their various organisations as they battled it out for the corporate champs title. The racing on the water for the duration of the event was exceptional and the Waikato weather provided some great racing conditions. The level of skill, sportsmanship, and whanaungatanga throughout the event was impressive. There was however a decrease in participation numbers of 800 paddlers compared to the 2021 event statistics, specifically across the taitamariki and intermediate divisions (6-13yrs). The lingering effects of covid have continued to impact our sport as well as ongoing socioeconomic pressures.

SECONDARY SCHOOL NATIONALS

28 - 31 March 2023 Lake Tikitapu, Rotorua

The Secondary School Nationals took place at Lake Tikitapu in March, hosted by Te Waiariki Purea Trust with support from Waka Ama NZ. The event, supported by manawhenua Ngāti Whakaue and Tūhourangi, was welcomed back by 1600 paddlers from 105 schools from throughout Aotearoa after the event was cancelled in 2022.

Event Overview

There were 170 races over the four day event including heats, semis, and finals across Te Ihu, Te Kei, and Te Takere divisions. The inclusion of multiple divisions provides more racing for rangatahi participating in the event.

Rotorua provided some clear, but at times chilly, conditions for the kaihoe (paddlers) as they battled it out on the water. The paddling skills displayed on the water was impressive but the sportsmanship and whanaungatanga between the rangatahi on land was even better. Our rangatahi make this event an exciting one and it was further amplified by our awesome announcing crew keeping them hyped with commentary and music.

Additionally, the Waka Ama NZ Rautaki Rangatahi (Youth Strategy) was officially released at the event by Te Reo Taiohi ropū (youth advisory group) members; a strategy codesigned with our Te Reo Taiohi ropū, to contribute to the development of waka ama for rangatahi, as advised by rangatahi.

For the first time the Laurie Durand Memorial Award - Te Pou Tautokohia was awarded at the event. This award pays homage to the late Laurie Durand, a stalwart of Te Waiariki Purea Trust, Waka Ama, and the National Secondary School Event.

LONG DISTANCE NATIONALS

21 - 23 April 2023 Te Whanganui-a-Hei, Whitianga

The Waka Ama Long Distance Nationals took place at Whitianga on the waters of Te Whanganui-a-Hei (Mercury Bay) in April, supported by haukāinga Ngāti Hei.

Event Overview

The event was organised and delivered by Te Puku o Te Ika Region, Whitianga Waka Ama, Hauraki Waka Ama, Te Āputa Tira Hoe and Te Whānau Waka Ama o Whangamata, in association with Waka Ama NZ. The event boasted a record number of participants with 1050 paddlers from 56 clubs participating across the three days of racing.

The windy conditions provided paddlers with some challenging conditions as they showcased their skills around a circuit course and launching from the beach was an exciting start to races as paddlers manoeuvred through breaking waves. There was some tough competition out on the water as teams and W1 paddlers were vying for a spot in the Aotearoa team for the International Va'a Federation World Distance Champs in Samoa.

ELITE TRAINING CAMP

22 - 23 July 2023 Ōkahu Bay, Tāmaki Makaurau

Aotearoa Waka Ama representative paddlers gathered at Ōkahu Bay, Tāmaki Makaurau, in July to take part in the Waka Ama NZ elite training camp in preparation for the 2023 IVF World Distance Champs in Samoa in August. The camp was focused on training preparation ahead of the world event and whanaungatanga within our Aotearoa contingent. The weekend included on the water training sessions, waiata and haka practice, and an official uniform presentation for each representative. Waka Ama NZ would like to acknowledge manawhenua Ngāti Whātua ki Ōrākei, sponsors Pure Athletic and Tai Paddles, Hyundai Marine Sports Centre and staff, coaches and management, paddlers, and our wider waka ama whānau for supporting this training camp.





The 3rd International Va'a Federation (IVF) World Distance Championships took place at Apia, Samoa, in August and was hosted by Samoa Outrigger Canoe Association with support from the IVF.

The event returned after the last event was held in 2019 and boasted a record number of approximately 900 paddlers from 27 different countries; the biggest ever world distance championships!

The Aotearoa contingent consisted of 91 paddlers and was represented in the team (V6) events from the Junior 16 to Master 70 divisions and in single-person (V1) events from the Junior 16 to Master 75 divisions; tane and wāhine categories. This also included our Para Mixed V6 team and 3 Para Men V1 paddlers. Aotearoa showcased a strong performance throughout all races for the duration of the event and topped the overall medal tally with a total of 24 medals (8 gold, 13 silver, 3 bronze). Medal or not, we are so proud of the achievements of our paddlers at this event and it is a true reflection of the high calibre of paddlers we have here in Aotearoa.

WHAKATAETAE WHAIKAHA

Para Events

Overview

It was a busy year for our para athletes as they competed in various world championship events around the world. One para mixed team and three V1 para athletes took part in the International Va'a Federation World Distance Championships in Samoa (10-18 August). It was awesome to see our para athletes representing Aotearoa on the world stage and we were fortunate enough to come away with a medal in each of the events that were entered.

Peter Cowan

Peter Cowan travelled to Sezged, Hungary, with coach Myk Nuku for the ICF ParaCanoe World Cup (11-14 May). Peter performed well and progressed through the heats and semis, and then placed 4th in the VL3 200m final. Peter then spent a five weeks training in Italy and France ahead of the world champs in August. The ICF ParaCanoe Sprint World Championships was held in Duisburg, Germany (23-26 August), and was also a qualifying event for the 2024 Paralympics in Paris. Peter again performed extremely well with some of his fastest recorded times, placing 2nd in VL3 200m for both the heat and semi races and finishing 9th in a very competitive final race. Peter now sets his sights to the next qualification chance at the World Champs in Hungary in May for the 2024 Paralympics. Peter continues to be a great ambassador and role model for our sport not only for para athletes, but for our whole waka ama community. We would like to acknowledge Peter's coach Myk for his continued support and guidance, the team at Canoe Racing NZ, and High Performance Sport NZ for all the support that you continue to provide.

Development

We continue to explore how to provide more opportunities and experiences for para paddlers. With the newly established Waka Ama NZ Te Ropū Whaikaha (Disability Working Group), we hope to further grow and develop waka ama for tangata whaikaha (disabled people).





WHAKATAETAE Ā-KARAPU

Club Events

Overview

Waka Ama regional and club events filled up the Waka Ama NZ events calendar with 11 regional events and 52 club events in the 2022-2023 season. It was great to see so many events happening throughout the motu and our paddlers engaging in the events. The inclusion of series within some regions was a highlight for the season as this provided paddlers with multiple paddling opportunities; namely, Hoe Tonga Paddler Series (Hoe Tonga clubs), Rotohoe Series (Ruamatā Waka Ama Club), and Hard and Fast Series (Ngā Hau Maiangi collective).

Event hosts continue to engage in the Waka Ama NZ sanctioning process for the events; a process in place to support events to meet relevant health and safety standards. A notable statistic regarding club events show that only 19% of the 52 club events catered to taitamariki and intermediate divisions, with the other 81% of events catering to rangatahi (youth) and pakeke (adult) divisions. Weather and environmental challenges had some major impacts on events in some regions, especially Te Uranga o Te Rā.

Development

A key focus for the 2023-2024 season is identifying ways to support regions and clubs to provide more participation opportunities for tamariki and rangatahi, including local events. The development of regions through the Aukaha project and the development of a club and school connection are two key activities that will support this.

Coaching Courses

Courses

There were 11 coaching courses delivered throughout Aotearoa in the past year by two facilitators. Attendance at each of the courses was good and there were 192 participants overall across all the courses. The amount of courses delivered and participants that attended doubled from the previous year which is a positive, however we still want to improve and provide more coaching and learning opportunities. Having enough facilitators to deliver our Waka Ama NZ coaching courses and on a frequent basis continues to be a challenge for us. This year, the world championships again had a massive impact on our ability to deliver courses as the majority of our facilitators were busy coaching or paddling as part of that campaign. We are aware of this challenge and continue to explore options to increase our number of quality facilitators.

Ngā Mihi

A big thank you to our coaching facilitators for their continued work within this space to deliver coaching courses to our waka ama whānau; Corrina Gage and Todd Jago. Thank you to our waka ama whānau for engaging in the available courses and for your contributions towards coaching within your hapori (community).





New Course

A new development level coaching course was initiated, Ngā Hapori o Waka Ama (communities), and is in the final stages of completion. This course provides participants with information and tools to understand, engage, and empower paddlers from diverse communities within Waka Ama. This course will be made available online through our newly established online learning platform Sport Tutor.

Sport Tutor

We are in the initial stages of launching our e-learning platform, Sport Tutor; a Sport NZ funded project that uses an online learning management system. This e-learning platform will enable us to provide online learning opportunities to help upskill our waka ama whānau throughout Aotearoa.

TE REO TAIOHI

Youth Advisory Group

Te Reo Taiohi is our Waka Ama NZ youth advisory group providing a voice for rangatahi who are involved in waka ama in Aotearoa.

Overview

The purpose of the ropū is to inform, advise, and provide insights to the Waka Ama NZ Board and Waka Ama NZ office from a rangatahi perspective. Te Reo Taiohi has been in operation for two years now and the first cohort, ropū tuatahi, finished their two-year term in August. The ropū continue to meet on zoom for hui and engage in korero via messenger; both of which seem to work well given the geographical circumstances of the ropu members.

Tuākana Ropū

Through the advice from the ropu, we implemented a Tuākana Rōpū from members of rōpū tuatahi. The purpose of the tuākana is to assist and support Waka Ama NZ Te Reo Taiohi Ropū activities alongside Waka Ama NZ Project Manager and foster a tuakana-teina relationship with Te Reo Taiohi Ropū members.

Rōpū Tuarua

Ropū tuarua, was established in September and was selected by way of online applications that was promoted online. This approach was different to the previous recruitment process, however proved to be successful with multiple rangatahi applicants from around Aotearoa bringing a diverse range of rangatahi perspectives to the rōpū. We look forward to working with the new rōpū and making progress towards achieving our Rautaki Rangatahi through their guidance.

Ngā Mihi

Waka Ama NZ would like to thank Te Reo Taiohi ropū tuatahi for their contributions and being the founding ropū members. It has been our privilege to engage with you all and we value the input you gave to the kaupapa, especially the legacy of developing the Rautaki Rangatahi. Thank you to ropū tuarua for putting your names forward to be a part of this kaupapa and we look forward to bringing the Rautaki Rangathi to fruition with your guidance.

SPORT NZ **YOUTH SPORT HUI**

Overview

Waka Ama NZ was invited to be a part of the annual Sport NZ Youth Sport Hui held in Tāmaki Makaurau in March. General Manager, Amiria, spoke to the audience of over one hundred kaimahi from the sport sector in regards to developing a rangatahi advisory group. The presentation focussed on the processes we undertook to establish the ropu, our current experiences engaging with rangatahi, key learnings from our experience so far, and helpful tips for developing rangatahi ropū.

Te Reo Taiohi Engagement

Additionally, two of our Te Reo Taiohi ropū members, Ngatuire and Manawa, took part in a youth discussion panel with three other rangatahi. The discussion panel focussed on providing insights from a rangatahi perspective of the importance and impact of rangatahi voices in organisations, their experiences in a rangatahi ropū, and what the future of sport looks like with rangatahi input. Ngatuire and Manawa did an amazing job and we thank them both for attending the hui, presenting to the audience, and representing Te Reo Taiohi and Waka Ama NZ so positively.

Waka Ama NZ are committed to engaging with rangatahi to support the development of waka ama throughout Aotearoa, and we hope that opportunities to share our knowledge with the sector inspire other organisations to engage with rangatahi too.



RAUTAKI RANGATAHI

Youth Strategy

Overview

The Waka Ama NZ Rautaki Rangatahi is a Youth Strategy, co-designed with our Te Reo Taiohi ropū, to contribute to the development of waka ama for rangatahi, as advised by rangatahi. Te Reo Taiohi ropū contributed to the development of this Rautaki Rangatahi through wānanga, online hui, and feedback via surveys and emails. The Rautaki Rangatahi was released in March at the Secondary School Nationals by four Te Reo Taiohi members during a prizegiving.

On average, our yearly affiliated waka ama membership consists of at least 50% under 19. Waka Ama NZ recognises the importance of rangatahi participation and engagement in waka ama, and the ongoing development required to ensure rangatahi needs are being met. This Rautaki Rangatahi sets the direction for Waka Ama NZ to be guided by our rangatahi and their voice.

RANGATAHI ENGAGEMENT SURVEY

The purpose of the survey was to gather insights from a captured audience at the 2023 Waka Ama Secondary School Nationals about Rangatahi Engagement in Waka Ama to further support the implementation of the Waka Ama NZ Rautaki Rangatahi (Youth Strategy).

The survey was conducted digitally on an iPad, led by a Te Reo Taiohi ropū member, at Lake Tikitapu, Rotorua. The survey received 100 responses from secondary school aged rangatahi.

100 Responses

97% want more waka ama events for rangatahi

Rautaki Rangatahi

The Rautaki Rangatahi is guided by our Waka Ama NZ Strategy and underpinned by our Waka Ama NZ values of Manaakitanga, Whanaungatanga, Hauora, and Tū Tangata. The rautaki has a strategic goal of increasing rangatahi involvement in waka ama; explained by the rangatahi as involvement in all aspects of waka ama, not just paddling. The four pou, strategic priorities, set the direction of the strategy; whakamana (empower), whakatairanga (promote), whakatuarā (support), and whakawhanake (grow). The rautaki will guide the ropū moving forward and provide aligned discussion points for rangatahi wānanga.

Activity Plan

The Year 1 activity plan from this strategy is currently being carried out and will lead the focus for the Te Reo Taiohi rōpū. Waka Ama NZ looks forward to the continuation of implementing this strategy and engaging with rangatahi to support waka ama development.

AUKAHA

Strengthen & Adapt Project

Overview

Aukaha is our Waka Ama NZ development project as part of the Sport NZ Strengthen and Adapt funding. Waka Ama NZ was a successful candidate after a thorough consultation period with our waka ama whānau and the submission of our Aukaha project plan. Aukaha will be implemented over the next 3-5 years with the support of Sport NZ. The Aukaha Project aims to strengthen the capability and capacity of waka ama at a regional and local level so that our sport can continue to grow, thrive and adapt

Project Manager

In August 2023, Waka Ama NZ employed our Aukaha Project Manager - Trevor Meiklejohn. Trevor brings with him a wealth of knowledge from the sporting sector and we are very excited to have him on board leading this project. Late September Trevor, with the support of our CEO, started facilitating sessions with each of our Waka Ama NZ regions. The purpose of these sessions were whanaungatanga and to gain valued input from our regions to ensure that the roll-out and shape of the project in each region aligns with the current and future needs of our sport.

Development

Over the next year, Aukaha will focus on strengthening regional entities in various areas, developing a regional support model, improving regional and club relationships, support funding opportunities for future growth, and develop capacity and capability of the kaimahi workforce. Aukaha has the potential to create positive change within our sport throughout Aotearoa and we look forward to the mahi ahead.

Balance is Better

We continue to promote and embody the philosophies of Balance is Better (BiB); to support quality sports experiences for all rangatahi regardless of ability, needs and motivations and ensure rangatahi stay in sport for life.

Balance is Better Champion

Waka Ama NZ is proud to announce that Peter Cowan is now a Balance is Better Champion. The purpose of the BiB Champions Programme is to engage champions (influential people) to carry BiB messages, speak about the value of sport in their lives, raise awareness of BiB, and advocate for change in youth sport and/or the value of sport to youth. In April, Peter attended a one day BiB Champions hui in Tāmaki Makaurau; to create connections between champions, ensure messaging and mahi is aligned, and identify future support needs. Peter is already a great role model for our waka ama whānau and we look forward to his additional impact through this programme.

We look forward to our continued mahi in this space to promote BiB within our waka ama whānau, merging opportunities between BiB and Te Reo Taiohi, and Peter's journey as a BiB Champion.

Disability Working Group

Waka Ama NZ is proud to establish Te Ropū Whaikaha o Ngā Kaihoe o Aotearoa (Waka Ama NZ Disability Working Group) for our Waka Ama whānau. Te Ropū Whaikaha is a working group providing a voice for tangata whaikaha (people with disabilities) who are involved in waka ama in Aotearoa. This working group, alongside Waka Ama NZ, will assist in increasing the access to and participation in waka ama for tāngata whaikaha in Aotearoa.

In September 2023 Waka Ama NZ called for expressions of interest from our waka ama whanau to establish the inaugural ropū. In 2024 the ropū will begin to meet and establish a plan to achieve the above objectives. Waka Ama NZ is excited to engage in this kaupapa and be a part of the development in the tangata whaikaha space.

Te Ropū Whaikaha Purpose

- Provide an opportunity for tangata whaikaha to voice their own experiences and perspectives on waka ama in New Zealand and advocate on behalf of the Waka Ama tāngata whaikaha membership
- Inform, advise, and provide feedback and insights to Waka Ama NZ Staff and Waka Ama NZ Board from a tāngata whaikaha perspective
- · Advocate on behalf of the Waka Ama tangata whaikaha membership throughout New Zealand
- Create and implement a Rautaki Whaikaha (Disability Plan) for Waka Ama in Aotearoa in collaboration with Waka Ama NZ
- Where necessary, provide delivery assistance for the Rautaki Whaikaha



Data and Insights

Data and Insights is an important part of the development of our sport; it helps with reviewing past trends, showcasing current achievements, and supports future planning within the Waka Ama NZ office. This information is important for us to understand and utilise to ensure our mahi is relevant and aligned to the needs of our waka ama whānau. We are in a space of learning and development in regards to understanding and utilising data and insights.

Survey

In April this year, we conducted a data and insights online survey. The purpose of this survey was to gather information from our Waka Ama NZ clubs and regions regarding our Waka Ama NZ statistics. The results from this survey will help us identify solutions to share for improving usage of data and insights.

We received a good number of responses, with 58 responses from 51 different clubs across Aotearoa. With the results of the survey we are now developing possible solutions and/or resources to support our clubs and regions in regards to understanding and utilising data and insights.

TAUTOKOHIA

Cyclone Support

At the beginning of 2023, parts of Aotearoa were severely affected by wet weather events and Cyclone Gabrielle. Unfortunately, this had massive impacts on some of our waka ama whānau and their personal assets, as well as waka ama equipment and the taiao (environment), meaning access to paddling was restricted for some.

Support

Te Uranga o Te Rā, Te Tai Tokerau, and Coromandel were impacted the most. Waka Ama NZ responded by checking in on our Waka Ama whānau and staff, assessing damage with affected clubs and sharing info with Sport NZ, shared cyclone assistance information, and connected with Regional Sports Trusts to access information for those requiring support. Additionally, Waka Ama NZ, with the guidance of Te Reo Taiohi, provided financial assistance to kura affected by the cyclone to attend the 2023 Secondary School Nationals by way of removing fees and providing a travel assistance koha for those kura in the most affected areas- Hawkes Bay, Tūranganui-a-Kiwa and the East Coast.

Long Distance Nationals

With the Long Distance Nationals scheduled to take place in the Coromandel only months after the weather events, consultation took place with all regional stakeholders and it was confirmed the event would go ahead in Whitianga with the full support of the council and community. The local organising crew worked with Thames Coromandel District Council to provide a roadmap to Whitianga including information for our whanau towing waka and driving to the event.

Waka Ama NZ would like to thank the clubs for their communication during that time, our affected waka ama whānau for their resilience, and to our wider waka ama whānau for the support given.
